### **SELECTBOARD MINUTES**

## IV. Business Items

#### A. Jim Kalloch – Snow Plow Contract

Kalloch would like to have the Snow Plow Contract amended. He would like to supply the sand and salt used on our town roads. He would still store it in the Town of South Thomaston's sand and salt shed. This would increase our yearly payment by \$29,500. Kalloch is doing this for St. George in the upcoming season and this would enable him to better utilize his equipment. He would have a supply at St. George and a supply in South Thomaston.

Also discussed was the possibility of Kalloch taking over the plowing of Route 131 for the State of Maine. 3 miles of Route 131 is in South Thomaston. A meeting is being held on July 25<sup>th</sup> in St. George to discuss this matter with MDOT, the Towns of Thomaston, South Thomaston and St. George.

One concern the Board has is who would be coming in and out of our sand and salt shed facility. Kalloch said only his trucks would be going back to the sand and salt shed. He would not be selling sand and salt out of there. He does that at his place of business.

Kalloch is willing to build up the base where trucks load so that they don't keep getting stuck.

There are two seasons left in our snow plow contract. The Town Attorney will update the contract. When this is done the board will get back in touch with Kalloch.

Reitz will talk with Town Attorney Kristin Collins about an amendment to the contract.

Reitz moved and Waterman seconded a motion to discuss a contract addendum approach with the Town Attorney to amend the contract to allow the contractor to supply the sand and salt.

Motion passed 3-0.

### B. Ambulance - New Hire Rose Piscuskas EMT

Waterman moved and Gaudio seconded a motion to accept Dyer's recommendation to hire Rose Piscuskas as an EMT.

Motion passed 3-0.
