## a. Painting the Little Red School House

Money to paint the little red schoolhouse will come from the Hopkins bequest. Alley would also like to re-shingle part of the building. There was a brief discussion on using volunteers as opposed to hiring a professional. Alley's proposal is tear off the old shingles on the two south facing walls, dip the new shingles and install with volunteer labor. The town would rent a lift as opposed to erecting staging.

The second part of the project is painting the remainder of the schoolhouse and repairing any trim that needs to be repaired. Alley will seek bids for the painting. Hopefully, this project can take place in early summer.

Spear moved and Gaudio seconded a motion to proceed with the plan that was outlined by Alley.

b. Gilford Butler School

Gaudio reviewed the 3 articles that were in the warrant included in the 2019 town report which were withdrawn and not included in the official warrant for the 2020 town meeting.

There was a discussion on the wording of article 18 and 19.

A discussion took place on the library using the building.

There was a brief discussion on low interest rates and the need for adequate community space. Other items were discussed, including renovation vs new construction.

Alley requested a public informational meeting be held concerning these articles.
