

**TOWN MEETING WARRANT**  
**Tuesday, June 28, 2022**

To Michelle Ames, a resident of the Town of South Thomaston, in the County of Knox, State of Maine,

GREETINGS:

In the name of the State of Maine, you are hereby required to notify and warn the voters of the Town of South Thomaston in the County of Knox and State of Maine, qualified to vote by law in Town affairs, to meet at the Ash Point Community School, 54 Ash Point Drive, Owls Head, Maine , on Tuesday, the 28th day of June 2022 A.D., at seven o'clock in the evening, then and there, to act upon the following articles to wit:

**Article 1.** To choose a moderator to preside at said meeting.

***Mike Mayo was elected by 4 votes.***

**Article 2.** To elect by written ballot one Selectboard member, one Assessor and one Overseer-of-the-Poor for a term until Town Meeting 2025.

**Sue Snow 83 votes**  
**Sandy Weisman 1 vote**  
**Blank 1 vote**

**Article 3.** To elect by written ballot one member for the Board of Directors of the Regional School Unit #13 for a term until Town Meeting 2025.

***Brad Choyt 82 votes***

**Article 4.** To see if the Town will vote to authorize payment to the Selectboard members and Assessors quarterly.

**Article 5.** To see if the Town will approve and authorize the Selectboard to execute an amendment to the September, 2006 Lease by and between the Inhabitants of the Town of South Thomaston and Wessaweskeag Historical Society to add the town owned Arlene Hopkins Memorial Building, also known as the "Little Red Schoolhouse" to the lease. A copy of the amended lease is posted with this warrant and will be available at the Town Office, on the Town Website and at the Town Meeting.

**Article 6.** To see if the Town shall vote to amend the current Inter Local Agreement between the Towns of Owls Head, South Thomaston and Thomaston establishing a Cooperative Solid Waste Transfer Facility.

Part 4.3 Financial Procedures currently reads:

(a) Budget. During the first year of activities hereunder, the Joint Board shall prepare a budget, determine recommended shares of costs and transmit the same to the member municipalities on or prior to May 1; thereafter, the budget and cost allocations shall be transmitted on or prior to January 1 of each year. This shall be the assessment for debt service and operating expenses for each member municipality.

(b) Fiscal Year. The fiscal year shall be from Jan 1 to Dec 31st.

(c) Audit. The Board shall engage a qualified public accountant to conduct an annual audit of the corporation's accounts. The audit shall be conducted on the basis of auditing standards and procedures prescribed by the State Auditor for municipalities.

Part 4.3 Financial Procedures: Shall be amended to read:

(a) The Joint Board shall prepare a budget, determine costs to be shared and transmit to the member municipalities on or prior to May 1, 2022. Thereafter, the budget and cost allocations shall be transmitted to the member municipalities on or prior to March 1 of each year. This shall be the assessment for debt service and operating expenses for each member municipality.

(b) The Fiscal Year shall be from July 1 to June 30 each year effective July 1, 2022

(c) is unchanged

**Article 7:** To see if the Town will vote (1) to authorize the Selectboard to form a nonprofit corporation to be called the Library and Community Center Auxiliary, which shall have the purposes and operate by the procedures set forth in the proposed Bylaws attached to this Warrant; and (2) to hold and appropriate all funds raised by said corporation and paid over to the Town, in the Selectboard's discretion, to be maintained and/or expended for the planning and construction of a library and community center at the site of the former Gifford Butler School.

***Spear moved and Northgraves Seconded a motion to vote Article 7 by written ballot.***

**Article 8:** Shall an Ordinance entitled "An Ordinance Regulating the Storage of Solid Waste and Junk" be enacted? A copy of the proposed ordinance is posted with this warrant and will be available at the Town Office, on the Town Website and at the Town Meeting.

**Article 9:** To see if the Town will authorize the Selectboard to:  
expend up to eight hundred fifty thousand dollars (\$850,000) to purchase or lease purchase a new tanker fire engine and a new or used utility fire truck;

Fund the expenditure substantially in accordance with the method list below;

Issue bond(s) or note(s) and/or execute a lease purchase agreement(s) in an aggregate amount of debt principal not to exceed \$438,683 for a term not exceeding seven (7) years;

Reduce the amount of the aggregate amount of debt issued, and/or contemplated to be issued, by any amounts of grants, donations or other funds that may be obtained for this purpose; and to;

Negotiate other such terms and conditions as it deemed advisable and necessary to complete the purchase and funding.

Fire Truck Reserve Fund: \$350,482

FY 24 Appropriation: \$60,835

Bond, Note and/or Lease Purchase Proceeds \$438,683

**Article 10.** *This article is strictly advisory and is not binding on the Selectboard.* To see if the Town desires that the Selectboard include an article on the warrant of the 2023 annual town meeting to determine if the town wishes to adopt the provisions of Title 30-A MRSA Section 2528. Adoption of Section 2528 would henceforth, until if and when repealed:

1. Require that all elected officials, excluding the Moderator, be elected by a referendum secret ballot vote at the polls, and
2. Enable the Selectboard, and petitioners, to submit certain articles or questions, at their discretion, to a referendum secret ballot vote at the polls.

Currently the only elected South Thomaston officials, other than the Moderator , is the town's member of the RSU 13 Board of Directors and the members of the Selectboard, who also serve as the Board of Assessors and the Overseers of the Poor.

**Article 11.** To see if the Town will vote to appropriate the sum of \$7,500 from the Town Landing Reserve Account to help support the Maine Lobstermen's Association's Legal Defense Fund to Save Maine Lobstermen.

**Article 28.** To see if the town will vote to charge interest on all delinquent taxes at the rate of 4 % per annum, computed on a daily basis and to establish two due dates for property taxes, with one-half of the tax amount due October 3, 2022, and one-half of the tax amount due April 3, 2023.

**Article 29.** To see if the Town will vote to set the interest rate to be paid by the Town on abated taxes at a rate of 4% and to authorize such interest paid or abatements granted to be appropriated from the overlay funds, or if necessary, from unassigned fund balance.




