I. Call to Order

Spear called the meeting to order at 6:00 pm.

II. Election of Board Chair

Baines asked for Nominations.

Spear nominated Northgraves. There were no further nominations.

Spear moved and Snow seconded a motion to elect Northgraves as Chair of the Selectboard.

Motion passed 2-0 Northgraves abstained.

III. Pledge of Allegiance

Northgraves led the Pledge of Allegiance.

IV. Adjustments to Agenda

Roadside Rescue and Diesel Services invoice, BC Electric invoice, Brief update on the shingling at the Little Red school house.

V. Public Comment for Items not on the Agenda

A member of the public commented that New Business c. should be dealt with in executive session or removed from the agenda.

There was a request to move New Business c., to earlier on the agenda.

VI. Review and Approval of Prior Meeting Minutes (June 8th, June 29th and July 6th)

Spear moved and Snow seconded a motion to approve the draft minutes of June 8, June 29 and July 6.

VII. Old Business

a. Update on Possible Land Purchases

Cline Properties

Map 008 Lots 003 and 002.

The Town has engaged Jim Strong for the purchase of the Cline property. Strong contacted Cline's attorney. Spear took a copy of the survey of the properties to Strong.

Snow moved and Northgraves seconded a motion to allow Spear to sign the purchase and sale agreement once Strong gives the green light.

Motion passed 2-0 Spear abstained.

Smith Properties

Map 008 Lot 005, Map 013 Lot 006, Map 009 Lot 006.

Smith would like to close on his properties within 60 days. The Selectboard discussed trying to accommodate Smith's timeline.

There was a discussion on the deed language/restrictions conveying Smith's intention for the property to be forever wild.

There was a brief discussion on grants and matches that may be available.

Spear talked with Doug Beck, Outdoor Recreation Manager, Bureau of Parks and Lands, about unencumbering the land used for the original tennis court grant. If the land is unencumbered the Town would not be able to get a grant to repair the tennis courts. Beck has requested the Town consider sending a letter requesting to unencumber the property. There was a brief discussion on encumbrances and how much of the property is involved. Sending the letter buys time but does not commit to anything.

Don Protheroe has offered to use his tractor to remove water off the old woods road. He will also repair the first gate.

b. Consider Supplemental Tax Assessment

Spear moved and Snow seconded a motion to assess Richard Jansen a supplemental tax of \$1,785.21 for tax year 2020, \$2,738.87 for tax year 2021 and \$1,878.25 for tax year 2022.

The Town is allowed to go back and recapture the last three years of taxes.

The Selectboard discussed the letter received from Jim Strong who represents Mr. Jansen.

i. Roadside Rescue Invoice

Roadside Rescue and Diesel Services no longer has liability insurance. Liability Insurance expired about ten days before the invoice date. There was a discussion on paying the invoice.

Baines will discuss with Phil that he check monthly that vendors have the required insurance. **Motion passed 3-0.**

i. BC Electric Invoice

Alley has spoken with Bob from BC Electric. The estimate he gave the Town did not include labor. The Selectboard discussed the estimate and the invoice.

Alley will reach out to Bob for more information.

Spear moved and Snow seconded a motion to have the Chair work it out with Terri and Pennie and if he works it out to his satisfaction authorize to pay it.
